New Father of the Company Elected

Following the sad passing of Alan Fowler the January Court considered who might be elected as his successor in this role. Past Master Bert Chapman MBE was proposed by Past Master Christopher Hayman, seconded by Past Master Joe Byllam-Barnes and elected unanimously by the Court. Bert joined the Court in September 1991 and became Warden to the Trade. He stepped down from this role to become Master in 2000/1 after which he resumed the role until April 2008. Even after this he has actively

enhanced our Livery's links with the Upholstery & Soft Furnishing trades and represents our Livery on the Livery Companies Wood Group and Construction Liveries Group. He is also very active as a Fellow of the AMU and travels the country arbitrating in disputes relating to his trade.



The Father of the Company, Past Master Alan C. Fowler, passed away on 3rd October 2010.

Alan was clothed in the Livery on 25th April 1954, joined the Court of Assistants on 21st January 1975 and was installed as Master of the Company in 1978.

Alan was a great supporter and promoter of the well being of the Company in thought, word and deed. He was remembered with great fondness at our January Court meeting.

Past Master Bert Chapman said; "Even in his last few days his strength of mind overcame his weakness, he remained jovial to the last. He will be remembered as a fine gentleman."

Past Master Christopher
Hayman said; "He was a
tremendous Upholder and a
great supporter in whatever
you did for the company."
He remembered Alan's wife;
after her death Alan took his
holidays travelling the world
on tankers and merchant
ships. "Alan," he said, with
the wholehearted support of
the Court, "was always held
in highest respect."

Past Master Hugh Taylor recalled the occasion of his installation when he reminded Alan that he had clothed Hugh in the Livery. Alan replied

with typical humour "oh you mean it's my fault!" During the dinner the Master reminded the company that Alan Fowler commissioned the model of the original HMS Upholder to celebrate our Naval links. Since the death of his wife the Livery had become his family. Indeed he has treated us as a family in his will with a substantial bequest. The Master invited members of the Livery to send suggestions for the use of this bequest to Jerry Appleyard, Nick Meyer or Richard Nevard who will present them for discussion in our April Court.

Freeman Les Beagen Celebrates his Centenary

It was a pleasure to receive, after the last issue of Upbraid, a most delightful letter from Mr LR Beagen. A Freeman since 1966, he joined the AMU in 1948 and celebrated his 100th birthday last June. Just to put many of us to shame he writes that he keeps up to date with news via the internet. Les is a prolific writer. He has written some 53 articles and two full books. These include his book "The Chaise Longue Story" and his booklet "My part in the Upholstery Industry" which is a series of short stories depicting his early days in the trade. The following is an extract:

"My father started life in the upholstery trade and mother made curtains and covers and I was constantly told the Upholstery trade was 'the' thing. After some looking about at the age of fourteen and a half I had an interview at an old established furnishing firm; the title above the door was impressive. House Furnishers, Cabinet Makers, House Decorators, House Agents, Funeral Furnishers, Removers and Storage. I was interviewed by the governor, a tall man with white hair and a beard, he wore a tail coat, pin stripe trousers and had a gold watch and chain which seemed to bear him down. After much probing I was told that I could start on a month's trial, after which I should, subject to satisfaction, become an indentured apprentice. My wages would be five shillings a week in the first year."

New Route To Joining the Livery - Friends

In line with our strategic plan the Court has approved a new route for joining our Livery. Those interested in joining but who do not have any previous connection can become Friends for one year. As friends they will receive invitations and Upbraid in the same way as Freemen, giving them an opportunity to understand the Company's aims and objectives and gain knowledge of our links with the Upholders' trades and the City as well as our charitable works. It is hoped that Friends will build friendships and contacts within our Livery.

At any point Friends can apply to become Liverymen or Freemen of the company and the Company will assist them through the usual process.

It is suggested that after making a donation (similar to the annual Quarterage Fee), Friends will enjoy their first Court dinner free of charge. The Friend's membership is not renewable but may be extended while their application is proceeding if they apply for Livery or Freeman status.

Back to the Future: Election of Master & Wardens Returns to 1626 procedure.

The sharp mind of Liveryman Stephen Dolland spotted that the Upholders' rules and procedures for election of the Master and Wardens adopted in 1948 and 1998 were at odds with our Charter granted in 1626. After careful study it is clear that our Charter takes precedence.

Therefore on January 13th
2011 the Master convened a
Common Hall with the words;
"Brother Liverymen and Freemen,
we are met here today in
accordance with the provisions of
our Royal Charter of 1626, to elect
a Master and two Wardens of this
Company, who shall go forward

for installation on Thursday April 13th 2011 for a period of one year."

So some 37 Liverymen and Freemen came together in the Court room of Vintners' Hall, fittingly one of the oldest in the City, for this election.

Nominations for election must be submitted in writing to the Clerk at least 2 weeks in advance and to be eligible candidates must be members of the Court and put in writing their willingness to serve. On this occasion only 3 nominations were received and after the clerk had confirmed the candidates' eligibility the commonality elected Jim Kelly as Master, Jeremy Appleyard as Senior Warden and Montague (Nick) Meyer as Junior Warden for the coming year.




Celebrating Our Naval Connections Mercers' Hall
